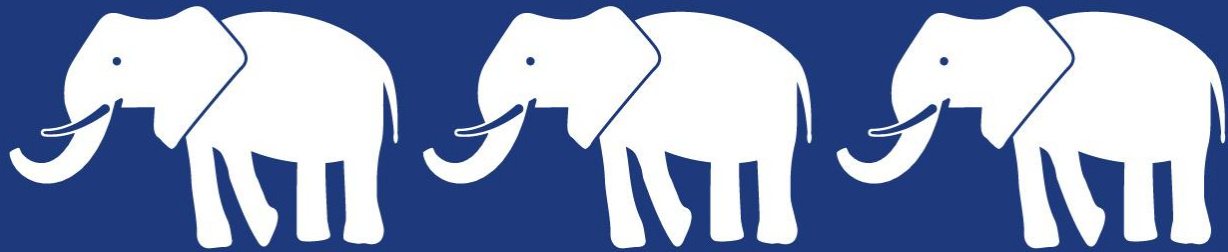

<b>Aims/priorities:</b>	<p>The Arts Award Access Fund is offering grants to Arts Award centres working on Arts Award projects with young people for whom access and inclusion is an issue. Priority will be given to centres that are working with young people for whom access and inclusion is an issue.</p> <p>This can include young people that:</p>	


	<ul style="list-style-type: none"> <li>• are disabled</li> <li>• have special educational needs, learning difficulties, or other specific individual requirements</li> <li>• live in areas of rural isolation and/or socio-economic deprivation</li> <li>• are in the youth justice system</li> <li>• are looked after by foster carers or in residential children’s homes</li> <li>• are young carers or young parents</li> <li>• are in a specific minority group (eg. 

<b>Aims/priorities:</b>	Voice4Change has launched a second round of their Covid-19 Partnership Fund to help small BAME-led organisations tackle the disproportionate impact of Covid-19 on Black, Asian and Minority Ethnic (BAME) communities in England. The fund will provide organisations with grants to deal with emerging issues in the community, as a result of the continuing threat of coronavirus, the need for self-isolation, and potential for further exacerbation of loneliness and isolation. Groups can apply for help with current costs to deliver Covid-19 services, including mental health and wellbeing services and sports activities.
<b>Who can apply?</b>	Smaller BAME-led charities, voluntary and community groups, and social enterprise

<b>Strategic Legal Fund (SLF) for Vulnerable Young Migrants.</b>		
<b>Aims/priorities:</b>	<p>Organisation that work with young migrants can apply for grants through the fund.</p> <p>Grants are available to undertake strategic legal work to benefit children and young people (under the age of 25) who are significantly disadvantaged by migration status. The fund will accept applications in any area of law that affects:</p> <ul style="list-style-type: none"> <li>• Migrants or the children of migrants,</li> <li>• Who are under 25,</li> <li>• Who are living in poverty,</li> <li>• Who face significant disadvantage or discrimination in connection with their (or their parents') migration status.</li> </ul>	

	The SLF only funds two kinds of strategic legal action- pre-litigation research and "third party intervention" in an existing case. The maximum grant length is 12 months, and most grants are for around six months.
<b>Who can apply?</b>	Not for profit organisations and private law firms
<b>Grant amount:</b>	The maximum grant available is £30,000, however, the average grant size is around £12,000
<b>Application process:</b>	Prospective applicants need to get in touch with ILPA to outline their proposal. If your request for funding fits the eligibility criteria, they will send out the application form to complete.

## The Ragdoll Foundation



<p><b>Aims/priorities:</b></p>	<p>Organisations that are working with children and young people using the arts and creative media can apply for funding. The Foundation's vision is to support projects where the concerns of childhood can be heard. A variety of art forms can be supported including dance, drama, ceramics, creative play, film, music, puppetry and storytelling. Supported projects need to support equality of opportunity, can include families and take place in rural or urban settings and may be delivered, for example, in children's and community centres, nurseries, schools and hospitals.</p> <p>Funding is available through two programmes:</p> <ul style="list-style-type: none"> <li>• Main Grants Programme –are available for new, larger or longer-term projects. Projects can last for up to three years.</li> <li>• Small Grants Programme. Organisations can apply for one-off projects, pilot projects, or research and development projects lasting up to 6 months.</li> </ul> <p>Preference will be given to those projects which have a deep commitment to listening to children and allow the perceptions and feelings of children themselves to be better understood. The Foundation is mainly interested in applications that involve children during their early years, but appropriate projects for older children (up to 18 years) will also be considered.</p>



<b>Aims/priorities:</b>	England Woodland Creation Offer is one of a suite of Forestry Commission initiatives to support woodland creation and tree	


	planting across England. Landowners, land managers and public bodies can apply to the England Woodland Creation Offer for support to create new woodland, including through natural colonisation, on areas as small as 1 hectare. The grant will cover standard capital costs for tree planting (up to a per hectare cap), as well as rewarding farmers and landowners for providing public and/or wider environmental benefits.
<b>Who can apply?</b>	Owner occupiers, tenants, landlords and licensors who have full management control of the land in the application (or consent from those who do).
